# 2007-2009 Biennial Report

The 2007-2009 biennium has brought many great opportunities and challenges to Tau Beta Sigma. While our Sorority is still recognizable to the organization that convened in Orlando, Florida for the 2007 National Convention, many significant changes have occurred, growing us ever stronger.

Financially, the Sorority continued its focus of operating and implementing programs based upon our available income. Recruiting and retention programs were implemented, giving our Chapters tools and information aimed at sustaining their membership. At the same time, we experienced Chapter and membership expulsions as the result of numerous violations of Tau Beta Sigma's Policy on Hazing. These expulsions came at great cost to the Sorority, with a significant amount of general funds being diverted to cover investigation expenses and the loss of Chapters & Members found guilty of hazing.

With a continued focus on ensuring the Sorority's financial future, the Board of Trustees strengthened our fundraising efforts, which significantly increased our Trust Fund income. These efforts were timely, as they compensated for investment losses when the worldwide financial market seriously weakened.

A major area of growth for TBΣ was through our Life Membership program, which has been a primary source of funding for many of our valuable long-term programs, including the National Intercollegiate Band, Commissioning Project, Women in Music Speaker Series, scholarships and leadership development. As we moved into the biennium, the Board of Trustees identified a continuing trend of increased costs for these programs and presented a recommendation for the 2009 National Convention Delegation to increase the Life Membership fee for the first time since 1997.

In addition to the numerous accomplishments of our Chapters, National Council, Board of Trustees and National Headquarters Staff, many alumni and life members, as well as friends, volunteered their time and energy to advance various programs & projects of the Sorority. The Tau Beta Sigma Alumni Association Executive Committee grew a membership base from inception and developed a fantastic array of alumni-focused programs. The National Historian and History & Archives Committee worked toward realizing our goals of having viewable archives at our National Headquarters. Our District Professional Relations Officers provided a Director's point of view when asked. Alumni and Life members stepped up as Colony Advisors. And, our District Counselors served daily as advisors when called upon by the National Council, Districts and Chapters.

To each and every one of our volunteers and supporters, we extend a sincere THANK YOU for all of the personal time and energy that you have devoted to TBΣ.



# National Highlights

**Affinity Consultants Licensing Agreement** entered into by TBΣ & KKΨ - Any vendor who creates items with our marks must enter into an agreement with Affinity, thereby ensuring that our trademarks are being protected

**Take A Stand for Tau Beta Sigma** became a rallying cry in the Spring of 2008 to all members in response to hazing concerns and incidents - The National Council took the stance that education is important and went public with expulsions of Chapters & Members that violated our Policy on Hazing

**2008 National Headquarters Staff** saw the retirement of Dixie Moser-Greene, a 22 year NHQ veteran, & the creation of an **Alumni, Chapter and Colony Affairs** position, which is shared between three part time employees

This biennium we unveiled the TBΣAA, which has experienced tremendous growth with over 300 members as well as the development of fantastic alumni focused programs & workshops for this year's National Convention

Lt. Col. Bonner, Dr. Matney and Mrs. Sigle presented a session on the growing hazing issues we are facing on HBCU campuses at the April 2008 **Annual HBCU Directors' Consortium/Black Band Directors Association Meeting** - This presentation included all hazing incidents in both organizations since 1996, along with our findings

Six district **Professional Relations Officers** (PROs) were appointed this biennium - These Directors of Bands were called upon to help communicate with potential Directors when needed & to assist our Counselors when working through situations that needed a Director's viewpoint

**Alumni/Life Policy for attending District & National Conventions** launched for the 2009 District Convention season - All attendees are required to be either a Life Member of TBΣ or a member of the TBΣAA, which protects the organization from an insurance standpoint and ensures that all in attendance are aware of our current policies and agree to abide by them

Over **3,000 Active Members and 135 Active Chapters** accounted for at the end of the 2009 fiscal year

**11 New Colonies** started for 2007-2009 Biennium

**5 New Chapters** installed for 2007-2009 Biennium

**9 Colonies** in place as of July 2009

**Tau Beta Sigma Recruiting DVD** launched at 2007 National Convention, with copies sent to 100 colleges & universities that do not have a TBΣ Chapter

Implemented a **Win-Win Membership Drive** for 2007-2009 Biennium

Created a **Recruiting/Retention Workshop** for all Chapters to conduct an internal audit on their membership growth

**2008 District Leadership Conference** held for in Oklahoma City, Oklahoma

A **National Committee for History & Archives** was formed with a group of Alumni and Life members cataloging, organizing, and restoring the history and historical objects of the Sorority, with the goal of remodeling a portion of the National Headquarters as a history-viewing salon

Chapters were encouraged to form a **Scouting for Music** relationship with Girl Scout and Boy Scout troops in their area

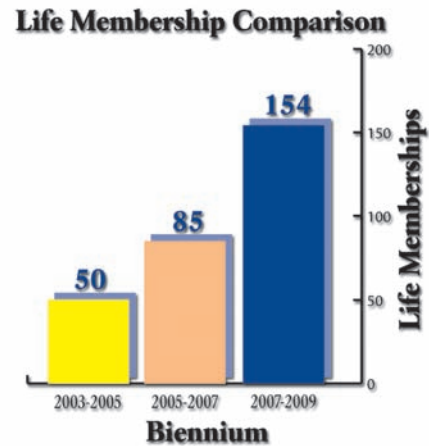
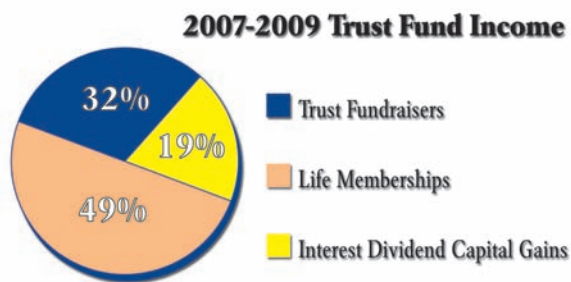
